WAIVER OF LIABILITY AND AGREEMENT TO INDEMNIFY

The undersigned acknowledges that he/she desires to perform certain services (collectively, "Services") for Okanogan Regional Humane (OK-Humane), a Washington nonprofit corporation. The undersigned further understands and acknowledges that certain risks may be associated with performing the Services.

In consideration of being permitted to perform services for OK-Humane, the undersigned, for himself/herself and his or her heirs and representatives voluntarily and knowingly executes this document and expressly waives any and all rights, claims or causes of action including without limitation those involving bodily injury or property damage to the Undersigned, or to the Undersigned's family or property while the Undersigned is engaged, directly or indirectly, in performing the Services, whether or not caused by the negligence of OK-Humane, its officers, directors, agents or employees.

In further consideration of being permitted to perform the Services for OK-Humane, the Undersigned hereby agrees to indemnify, defend and hold OK-Humane, its officers, directors, agents or employees from and against any and all liability, damage, loss, cost and expense incurred as a result of any claim, demand, or cause of action, brought against OK-Human, its officers, directors, agents or employees, jointly or individually, for bodily injury or property damage suffered as a result of the Undersigned's negligent, reckless or willful act or omission in the performance (or failure to perform) of Services.

Understanding that public relations are an important part of a volunteer's activities on behalf of OK-Humane, I hereby authorize OK-Humane to use any photographs of me in its possession for public purposes. I ask that OK-Humane use reasonable efforts to give me advance notice of any such use but such notification is not a condition to release photographs for public use.

Client confidentiality must be maintained and no disclosure of client information will be disseminated. No information regarding privacy of staff, facility operations, or conversations meant to be private will be shared with anyone outside of Okanogan Regional Humane.

The Undersigned has read and fully understands the contents of this waiver of Liability and Agreement to Indemnify. This Waiver of Liability and Agreement to Indemnify shall continue in full force and effect until terminated in writing and in the event of such termination shall remain applicable to all matters occurring or first rising on or before the date of such termination regardless of such termination.

The Undersigned also acknowledges that he/she will not be paid any compensation for volunteer hours served.
